13 AN ORDINANCE AMENDING THE FY 2019-20 BUDGET, ORDINANCE NO. 2019-20, BY
14 UPDATING SECTION 5, EDUCATION APPROPRIATION, FOR THE SCHOOL DISTRICT'S
15 APPROVED BUDGET AMOUNT

17 WHEREAS, Ordinance No. 2019-20, was approved by the Assembly on
18 May 9, 2019; and

20 WHEREAS, AS 14.14.060(c) and FNSBC 7.12.040(A) require Assembly
21 approval of the total amount of the Fairbanks North Star Borough (Borough) School
22 District budget; and

24 WHEREAS, The School Board met on Tuesday, May 21st, and authorized
25 Resolution 2020-01, "Adoption of the FY 2019-2020 School District Approved Budget",
26 increasing the District's final budget amount.

28 NOW, THEREFORE, BE IT ORDAINED by the Assembly of the Fairbanks
29 North Star Borough:

31 Section 1. Classification. This ordinance is not of a general and
32 permanent nature and shall not be codified.

34 Section 2. Amendment to Section 5, Education Appropriation.
35 Fairbanks North Star Borough Ordinance No. 2019-20, Section 5, is amended as
36 follows:


37 As required by AS 14.14.060(c) and FNSBC 7.12.040(A), the sum of
38 \$181,263.096 [\$178,698,839] plus the amount of the final Borough adopted
39 contribution to education plus the amount of on-behalf payments from the State
40 of Alaska for PERS and TRS is hereby approved as the total amount of the
41 Fairbanks North Star Borough School District budget for the fiscal year beginning
42 July 1, 2019 and ending June 30, 2020. This amount is not appropriated.
