9 A RESOLUTION AUTHORIZING THE MAYOR TO SUBMIT AN APPLICATION TO THE  
10 ALASKA DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES 2020-2023  
11 COMMUNITY TRANSPORTATION PROGRAM FOR PUBLIC ACCESS IMPROVEMENTS FOR  
12 PHASE TWO OF THE TANANA RIVER RECREATION ACCESS IMPROVEMENTS PROJECT  
13

14 WHEREAS, The Fairbanks North Star Borough (Borough) Assembly  
15 adopted Resolution No. 2019-17, authorizing an application to the Alaska Federal Lands  
16 Access Program (AFLAP) for Phase Two of the Tanana River Recreation Access  
17 Improvements Project; and  
18

19 WHEREAS, The project budget for Phase Two is expected to exceed the  
20 AFLAP funding limits; and  
21

22 WHEREAS, The Borough has been invited to apply for additional funding  
23 available under the Community Transportation Program (CTP), administered by Alaska  
24 Department of Transportation and Public Facilities (AKDOT&PF), for the purpose of  
25 creating and promoting the planning and development of transportation projects in  
26 Alaska; and,

28 WHEREAS, The Borough is a qualified applicant for the CTP grant; and  
29

30 WHEREAS, If awarded, CTP funds would allow for design and construction  
31 of the entire project scope for Phase Two of the Tanana River Recreation Access  
32 Improvements project; and


34 WHEREAS, Phase Two of the Tanana River Recreation Access  
35 Improvements Project would provide access that meets the Americans with Disability  
36 Act (ADA) regulations, restroom facilities, improved parking, and important road  
37 connections to existing infrastructure as proposed in the 2016 and 2019 AFLAP  
38 proposals and the 2007 Borough-approved Tanana Lakes Recreation Area master plan;  
39 and

41 WHEREAS, A CTP grant requires a 9.03% local match and a maintenance  
42 agreement between AKDOT&PF and the Borough before beginning construction of this  
43 project.


44 NOW THEREFORE BE IT RESOLVED that the Assembly of the Fairbanks  
45 North Star Borough hereby authorizes the Mayor to submit a proposal to the Alaska  
46 Department of Transportation for the 2020-2023 Community Transportation Program  
47 matching grant for Phase Two of the Tanana River Recreation Access Improvements  
48 Project.
