9 A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A MAINTENANCE
10 AGREEMENT WITH THE ALASKA DEPARTMENT OF TRANSPORTATION AND PUBLIC
11 FACILITIES AND ACCEPTING MAINTENANCE RESPONSIBILITIES FOR THAT PORTION
12 OF THE BIRCH HILL RECREATION AREA AND SOUTH DAVIS PARK ACCESS ROADS
13 THAT SHALL BE RENOVATED UNDER THE FAST IMPROVEMENTS PROGRAM IRIS
14 DESIGN #NFHWY00346 AND IRIS CONSTRUCTION #NFHY00434

16 WHEREAS, The State of Alaska, Department of Transportation and Public
17 Facilities (AKDOT&PF) is scheduled to complete drainage and surfacing improvements
18 to the access roads within the Birch Hill Recreation Area and South Davis Park; and
19

20 WHEREAS, The Fairbanks North Star Borough (Borough) is the owner of
21 the Birch Hill Recreation Area and South Davis Park, and
22

23 WHEREAS, The roads within these parks are heavily used and require
24 regular maintenance to maintain a smooth driving surface; and
25

26 WHEREAS, This project will resurface these roads and make drainage
27 improvements which will extend their life and improve the driving surface, benefitting
28 residents of the Borough; and
29

30 WHEREAS, The AKDOT&PF requires a maintenance agreement be entered
31 into with the Borough before beginning construction of this project.

33 NOW THEREFORE BE IT RESOLVED by the Assembly of the Fairbanks
34 North Star Borough that the Mayor, or his delegate, is hereby authorized to execute and
35 sign on behalf of the Fairbanks North Star Borough a Maintenance Agreement between
36 the Fairbanks North Star Borough and the State of Alaska, Department of
37 Transportation and Public Facilities for the Birch Hill Recreation Area and South Davis
38 Park Access Roads to be completed by the FAST Improvement Program projects: IRIS
39 #NFHWY00346 and IRIS #NFHWY00434.
